### Venue and Date

Shree L. R. Tiwari College of Law's Vidhiprabha, the 4th National Law Fest, shall be held on 7<sup>th</sup> March, 2026 and 8<sup>th</sup> March, 2026.

### Language

The language of the Fest shall be English only.

## ELIGIBILITY FOR PARTICIPATION

1. Participants from all backgrounds, genders, and geographies are welcomed.
2. The event is open to everyone who is at least 18 years of age and is currently enrolled in a program of study of minimum two-year duration (B.L.S., LL.B. / B.A.I.L.B. / LL.B. / LL.M.) in a recognized University / College and has a valid ID card of the University / College.
3. The Organizing Committee of Shree L. R. Tiwari College of Law can close the registration to any of its competition/s without any notice whenever it deems fit.
4. Participants must not be students who are suspended / removed / debarred by their own College / University.

## REGISTRATION

1. Registration for all events shall be done online through the links provided in the brochure. Teams will be registered on first come first serve basis.
2. No temporary registration requests will be entertained. Kindly refrain from sending such requests to the Organizing College.
3. Participants will receive an acknowledgement on successful submission of registration. Participants will also receive an approval as acceptance of their request for participation latest within 24 hrs.
4. The Registration form cum Approval letter as provided in the rules duly signed & sealed by your College / University.
5. Fee once paid will not be refunded.
6. The participating institutions have to register by filling up the Google form (links for each event have been given below) on or before 7<sup>th</sup> February, 2026 by 11:59 PM (IST).

2. If any one of the members of a team is notified or informed of any detail or information concerning the Competition, it shall be deemed as if the said team as a whole has been duly notified or informed.
3. The Organizing Committee reserves the right to amend, alter, vary or change, in any manner whatsoever, the Rules governing the Fest or any of the events, which would be communicated to the teams within a reasonable period.
4. The Organizing Committee and the Organizing College, as mentioned in these Rules, refer to the Organizing Committee of Vidhiprabha, the Country Level Law Fest, Shree L.R. Tiwari College of Law.

## EVENTS OF THE FEST

### 1. Law Quiz

The Law Quiz shall test the legal knowledge of participants on various arenas of law. Participating colleges can send in their registrations in teams of two. Maximum one team per college can participate.

## RULES AND REGULATIONS

- a. A team shall comprise of only two students.
- b. Language of quiz shall be English.
- c. The participants are not allowed to use mobiles or any other electronic devices during any of the rounds of the event.
- d. Organizing committee may alter /change the rules and regulations at any point of time.

## REGISTRATION OF PARTICIPANTS

1. All applicants must register as a team and state the details of individual members on or before **7<sup>th</sup> February, 2026**. Registration should be done through the online registration form through the link <https://forms.gle/w7Mcr5gzks1QyMp7A>
2. Each applicant must enter the required information on the registration form. No late submissions will be accepted and any incomplete, false, erroneous, fraudulent, forged, or tampered forms will not be considered.
3. Once the participants are registered, they should view all information, rules and regulations, and relevant details given in the brochure.

## ROUNDS

\* Rounds & number of questions can be changed according to the number of teams registered for the event.  
There will be one winning team only.

### ROUND-I

1. Each team shall answer multiple choice type questions based on Legal knowledge/General Awareness/Current Affairs.
2. The questions shall be projected through a PowerPoint Presentation in an Audio-Visual format.
3. There shall be plus 10 for each correct answer & minus 5 for each wrong answer.
4. Teams can deny answering any question if they want and that will not affect their marking. However, that question will get passed to the next team.
5. 60% of the total teams shall qualify to the Round-II.\*

### ROUND-II

1. Each team shall answer multiple choice type questions based on Law of Contract 1872, Family Law, JURISPRUDENCE, CRPC, CPC, Constitutional Law of India, Law of Torts & Indian Penal Code 1860.
2. The questions shall be projected through a PowerPoint Presentation in an Audio-Visual format.
3. There shall be plus 10 for each correct answer & minus 5 for each wrong answer.
4. Teams can deny answering any question if they want and that will not affect their marking. However, that question will get passed to the next team.
5. 40% of the total teams shall qualify for Round III i.e., the Final Round.

## ROUND-III

1. Each team shall answer questions based on Bharatiya Nagarik Suraksha Sanhita, 2023 and Bharatiya Sakshya Adhiniya, 2023
2. The questions shall be projected through a PowerPoint Presentation in an Audio-Visual format.
3. There shall be plus 10 for each correct answer & minus 10 for each wrong answer.
4. Teams can deny answering any question if they want and that will not affect their marking. However, that question will get pass to the next team.

Mooting is the oral presentation of a legal issue or problem against an opposing counsel and before a judge. Moot court helps a budding lawyer to build confidence in public speaking, general research, and presentation skills.

## **MOOT PROPOSITION (SUMMARY)**

Writ Petition filed by a Student regarding Social Media Takedown & Police Action

(For ..... Moot Competition, 2025)

## BACKGROUND

Aarav Mehta, aged 19, is a first-year student at Western Metropolitan College, Luminora. He manages a popular Instagram page called “Luminora Unfiltered”, known for posting humorous memes on public life, city infrastructure, and government decisions. The page grew rapidly and, by July 2025, had over 42,000 followers, mostly college students.

On 11 July 2025, Aarav posted a meme satirizing the newly announced “City Mobility Optimization Policy” of the Government of Luminora.

The meme became viral within hours, generating thousands of shares and comments. Several users tagged political leaders, journalists, and government handles, calling the policy “impractical”.

The post also triggered heated exchanges on social media. A few politically affiliated student groups complained online that the meme “misrepresented” the policy and was being used to ridicule a senior Minister.

On 12 July 2025, a series of online complaints were submitted through the State Cyber Complaint Portal alleging that the meme was “provocative”, “misleading”, and “capable of disturbing commuter behaviour”.

On the morning of 13 July 2025, officials from Luminora Police’s Cyber Cell delivered a notice at Aarav’s residence asking him to appear for inquiry. The notice mentioned that an investigation had been initiated based on the online complaints. It also stated that Aarav should bring the device used to post the meme.

Later that afternoon, a message was circulated among student groups claiming that “Aarav is being targeted for political criticism.” This message led to spontaneous gatherings inside Western Metropolitan College. Students held placards reading “Let Memes Live” and “Don’t Block Youth Voices”. The gathering lasted about 2 hours and dispersed peacefully after college authorities intervened.

On the same day, local news channels picked up the story and reported that “Luminora Police questions student for meme on Minister”. Several media discussions debated whether memes should attract police action.

## GOVERNMENT ACTION

On 13 July 2025, the Assistant Commissioner of Police submitted a brief report to the Home Department, Government of Luminora, stating that the meme had “sparked unrest among student groups” and had “potential to escalate”. The report recommended temporary preventive measures.

That evening, an order was issued directing that circulation of “misleading or provocative online material relating to the Mobility Policy” should be restricted for the next 48 hours. College authorities across South Mumbai were requested to monitor student gatherings.

On 14 July 2025, the Luminora Home Department forwarded the police report to the Luminora Ministry of Electronics & Information Technology (LMeitY), recommending that the Instagram page “Luminora Unfiltered” be temporarily blocked as “a preventive step”.

On 15 July 2025, Instagram disabled access to the page for all users within India. The notification sent to Aarav simply stated that the page had been “restricted based on a request from authorities”.

Aarav claims he received no prior notice of any proposed action against his page. He also states that the device taken for “verification” had important academic material, which he could not access during examination week.

Following the blocking, student groups from four Luminora colleges organised online campaigns urging the authorities to restore the page. Several hashtags trended locally for a day.

## EVENTS LEADING TO THE COURT CASE

Aarav's parents approached the college principal on 16 July 2025, expressing concern about the police involvement. The principal informed them that the college had not filed any complaint and suggested seeking legal advice.

On 17 July 2025, Aarav was informed by Instagram that he could not appeal the takedown because the restriction was "government directed".

Aarav alleges that the action taken by multiple authorities—Luminora Police, Luminora Home Department, and LMeitY—was "excessive, sudden, and without transparency".

He maintains that the meme was harmless satire and that he never intended to create public disturbance.

He further states that the blocking of the page has affected his reputation, as several of his classmates now assume he engaged in wrongdoing.

After consulting lawyers, Aarav decided to approach the Luminora High Court through a Writ Petition, challenging the actions taken against him and seeking directions related to his social media account and ongoing inquiry.

The petition was filed on 20 July 2025.

The matter has been admitted and is now listed for final hearing.

City of Luminora = City of Mumbai; all laws prevailing in the City of Mumbai will be applicable to City of Luminora

The matter is listed for **final disposal on 8th March, 2026.**

### 3. CLIENT COUNSELLING

The Client Consulting Competition is intended to explore the client-lawyer interaction skills and to improve the problem analysing techniques of the students and giving such information which, a client would like to know regarding his legal problem/case.

## 4. PROPOSED BILL/AMENDMENT PRESENTATION GENERAL INTRODUCTION

As part of the 4th Country Level Law Fest, the Proposed Bill/Amendment Presentation Competition aims to encourage law students to critically engage with contemporary legal issues concerning women in India. Participants are required to conceptualize and present an original Proposed Bill or Amendment that addresses a pressing socio-legal concern faced by women. The competition provides students an opportunity to exhibit their drafting skills, legal acumen, and constitutional understanding while proposing constructive legislative solutions.

## RULES AND REGULATIONS

### 1. Theme:

- The proposed Bill/Amendment must be **women-centric** and address a **current, relevant legal need** concerning women in India.

### 2. Originality:

- The concept must be original, unique, and innovative. Plagiarism or duplication of existing laws will lead to disqualification.

### **3. Mandatory Format for Presentation:**

Each participant must strictly follow the structure provided below:

1. Short Name of the Bill (e.g., SAFE Bill, 2025)
2. Full Name of the Bill (e.g., Safety and Assistance for Female Empowerment Bill, 2025)
3. Justification & Importance
  1. Explanation of the need, significance, and impact of the proposed law
  2. Logical reasoning, examples, or data to support the proposal
4. Constitutional Compatibility
  1. The proposal must be practically implementable
  2. Must not violate the Basic Structure of the Constitution of India
  3. Should align with the existing legal framework

### **4. Presentation Guidelines:**

1. Each participant will be given 10-15 minutes to present.
2. Key features and relevance of the Bill/Amendment must be clearly discussed.

### **5. Defence Round:**

1. Participants must be prepared to answer questions regarding:
  1. Feasibility of implementation
  2. Legal validity and constitutional compliance
  3. Practical need and impact of the proposed legislation

### **6. Evaluation Criteria:**

1. Originality of concept
2. Legal reasoning and justification
3. Constitutional alignment
4. Clarity of presentation
5. Ability to defend the proposal

### **7. Disqualification:**

1. Failure to adhere to the format
2. Exceeding time limits
3. Submitting ideas that infringe basic constitutional principles

## ROUNDS TO BE CONDUCTED

### 1. Presentation Round:

- Participants will deliver a **10-15 minute presentation** on their proposed Bill/Amendment.

### 2. Question & Defence Round:

- Participants will respond to questions posed by judges regarding:
  - Legal soundness
  - Need and practicality
  - Constitutional validity
  - Implementation challenges

### 3. Final Assessment:
